Wheelock and Company Joins the Hang Seng HK 35

Effective June 17, 2013

June 14, 2013, Hong Kong – Wheelock and Company Limited (stock code: 20) today announces that the Company has been selected by Hang Seng Indexes Company as a constituent of the Hang Seng HK 35 index (“HSHK35”) effective June 17, 2013 to take the place of Foxconn International Holdings Ltd. The inclusion of the Company into HSHK35 signifies the Company’s robust foundation as well as its leading position in Hong Kong.

The HSHK35 comprises the 35 largest companies listed in Hong Kong which derive over 50% of their sales revenue (or profits or assets if more relevant) from areas outside the Mainland China. It provides a tradable index reflecting the performance of large-cap Hong Kong companies.

Wheelock’s inclusion in the HSHK35 not only endorses Wheelock and Company as one of the largest Hong Kong listed companies by market capitalisation and liquidity. It also confirms Wheelock is in market spotlight with both institutional and retail investors.

Headquartered in Hong Kong, the Company’s core profit for 2012 stood at HK\$7.3 billion, in which more than 60% of the revenue was generated from Hong Kong operations.
