POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 11 MAY 2018

At the Annual General Meeting of Wheelock and Company Limited (the “**Company**”) held on 11 May 2018 (“**AGM**”), a poll was demanded by the Chairman for voting on all the proposed resolutions as set out in the Notice of AGM dated 10 April 2018.

As at the date of AGM, the total number of issued shares of the Company was 2,047,349,287, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There is no restriction on any shareholders casting votes on any of the resolutions at the AGM.
